

**AMENDMENT NO. 1 TO
PROFESSIONAL SERVICES AGREEMENT
WITH AMERICAN GLOBAL SECURITY, INC.**

This Amendment No. 1 to the Professional Services Agreement is made and entered into as of July 1, 2023 (“Effective Date”) by and between the City of Upland, a municipal corporation (“City”) and American Global Security, Inc., a California corporation (“Contractor”). City and Contractor are sometimes referred to herein individually as a “Party” and collectively as “Parties.”

RECITALS

A. WHEREAS, the City and the Contractor have entered into an agreement, dated July 1, 2021 for the purpose of providing Metrolink Station Security Guard Services (the “Original Agreement”).

B. WHEREAS, pursuant to Section 1 of the Original Agreement, the City may extend the Original Agreement for up to three (3) additional one (1) year Terms.

C. WHEREAS, the Parties now desire to amend the Original Agreement in order to extend the term of the Original Agreement for one (1) additional year.

NOW, THEREFORE, in consideration of the above recitals and the mutual covenants, conditions, and promises contained in this Amendment No. 1 and the Original Agreement, the Parties mutually agree as follows:

AGREEMENT

1. Incorporation of Recitals. The recitals listed above are true and correct and are hereby incorporated herein by this reference.

2. Term. The term of the Original Agreement shall be extended for an additional term of one (1) year commencing July 1, 2023 through June 30, 2024 (“Extended Term”) unless earlier terminated.

3. Compensation. The compensation for services performed pursuant to this Amendment No. 1 Extended Term shall not exceed the total cost, as described in Exhibit B, for an aggregate amount not to exceed **\$153,342.70** for Security Guard Services.

4. Service Hours Adjustment. As described in the Original Agreement, Scope of Services Item 2.1 Estimates, Monday thru Friday security services shall increase 2 hrs. per day for a total of 19.0 hrs. per day to accommodate Metrolink train schedule adjustment.

5. Full Force. Except as amended by this Amendment No. 1, all provisions of the Original Agreement, including without limitation the indemnity and insurance provisions, shall remain in full force and effect and shall govern the actions of the Parties under this Amendment No. 1.

6. Electronic Transmission. A manually signed copy of this Amendment No. 1 which is transmitted by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment No. 1 for all purposes. This Amendment No. 1 may be signed using an electronic signature.

7. Counterparts. This Amendment No. 1 may be signed in counterparts, each of which shall constitute an original.
