

## **AMENDMENT NO. 2 TO AGREEMENT FOR BOOKING SERVICES**

This Amendment No. 2 is entered into as of July 22, 2024, by and between the City of Upland, a Municipal Corporation ("City" or "Customer"), and Allied Universal (previously known as "G4S Secure Solutions (USA) Inc.") a Florida corporation with its principal office located at 1450 Iowa Avenue, Riverside, CA 92507 ("Contractor," identified in the Original Agreement and Amendment No. 1 as "G4S"), with respect to that certain Agreement made and entered into on the 1st day of June, 2019, for booking services ("Original Agreement"), as amended by that certain Amendment entered into by the City and Contractor as of March 9, 2021.

WHEREAS Contractor and City entered into that certain Original Agreement for booking services that will, from time-to-time, be requested by the Upland Police Department whereby Contractor agreed to provide booking services (as Identified in Schedule A of the Original Agreement) through June 1, 2024 with the option to extend the contract for up to a three (3) year additional term, subject to the written consent of both parties; and

WHEREAS, Contractor and City agree to amend the Original Agreement as amended to extend the term for a 3 year term, from May 31, 2024 through June 1, 2027 and provide for the compensation of the continuing services on the terms and conditions set forth in the Original Agreement;

THEREFORE, it is agreed by City and Contractor as follows:

### **1. TERM OF AGREEMENT**

The Original Agreement, as amended, shall be extended through May 31, 2027.

### **2. FULL FORCE AND EFFECT**

Except as modified pursuant to Amendment No. 2, all other terms and conditions of the Original Agreement, as amended, shall remain in full force and effect.

### **3. RATES**

The parties agree that the rate sheets set forth in Exhibits "A" and "B" attached hereto and incorporated herein by reference shall apply, respectively, to the period June 1, 2024 through May 31, 2025, for which the total shall be \$229,211.40, and to the period June 1, 2025 through May 31, 2026, for which the total shall be \$239,074.04.
